A. LINKUS PROGRAM UPDATE - KIM SHARP, COTA SENIOR DIRECTOR OF DEVELOPMENT

COTA Senior Director of Development Kim Sharp presented an overview of the LinkUS Program strategy for 2025. Ms. Sharp reported that the West Broad BRT Corridor construction will start in 2025, and the East Main Street BRT Corridor Pilot Program will design for peak traffic and needs to take safety into account. Quarterly check ins with the Ohio Department of Transportation (ODOT) are planned for 2025.
